## **Description of Requirements:**

The United Nations Interim Administration Mission in Kosovo (UNMIK) has a requirement to upgrade and modify security arrangements in MHQ Compound in Pristina, Kosovo and RHQ Compound in Mitrovica, Kosovo.

Requirement is for the provision and installation of the bulletproof windows & doors. Below standards shall be met in term of protection for all installed windows and office doors:

BR-7 or FB-7 security level in accordance with EN 1063 or EN 1522 Security Glazing Standard. Bullet resistance test report in accordance with EN-1523 standard, both for the frames and the window glass.

Bullet resistant fiberglass wall panels characteristics should meet below standards in term of protection for all installed ballistic wall sheets:

Bullet resistant fiberglass wall panels thickness 12.50 mm to meet with the test standards EN 1063 BR-4. Bullet resistant fiberglass wall panels thickness 7 mm to meet with the test standards EN 1063 BR-2.

The Contract or its sub-contractor shall be in possession of all relevant permits, amongst them but not limited to the "Business Registration Certificate and License" for such services in Kosovo.
