**ADMINISTRATIVE DIRECTION NO. 2001/14**

**IMPLEMENTING UNMIK REGULATION NO. 2001/19  
ON THE EXECUTIVE BRANCH OF THE PROVISIONAL INSTITUTIONS  
OF SELF-GOVERNMENT IN KOSOVO**

The Special Representative of the Secretary-General,

Pursuant to the authority given to him under sections 6.1 and 8 of United Nations Interim Administration Mission in Kosovo (UNMIK) Regulation No. 2001/19 of 13 September 2001 on the Executive Branch of the Provisional Institutions of Self-Government in Kosovo,

Taking into account UNMIK Regulation No. 2001/9 of 15 May 2001 on a Constitutional Framework for Provisional Self-Government in Kosovo,

For the purpose of making transitional arrangements to facilitate the establishment of provisional institutions of self-government in Kosovo pursuant to UNMIK Regulation No. 2001/9 through the provisional reorganization of the Administrative Departments of the Joint Interim Administrative Structure (JIAS) into the Transitional Departments corresponding to the governmental structures set out in UNMIK Regulation No. 2001/19,

Hereby issues the following Administrative Direction:

Section 1  
Transitional Departments of the Interim Administration

The JIAS Administrative Departments established pursuant to UNMIK Regulation No. 2000/1 shall be provisionally reorganized into Transitional Departments as follows:

(a) The Transitional Department of Good Governance, Human Rights, Equal Opportunity and Gender to perform responsibilities and functions of the Administrative Department for Democratic Governance and Civil Society;

(b) The Transitional Department of Finance and Economy to perform responsibilities and functions of the Central Fiscal Authority and the Administrative Department of Reconstruction;

(c) The Transitional Department of Trade and Industry to perform responsibilities and functions of the Administrative Department of Trade and Industry and the Administrative Department of Public Utilities;

(d) The Transitional Department of Education, Science and Technology to perform responsibilities and functions of the Administrative Department of Education and Science;

(e) The Transitional Department of Culture, Youth and Sports to perform responsibilities and functions of the Administrative Department of Culture, the Administrative Department of Youth, the Administrative Department of Sports and the Administrative Department of Non-Resident Affairs;

(f) The Transitional Department of Health, Environment and Spatial Planning to perform responsibilities and functions of the Administrative Department of Health and Social Welfare (health responsibilities and functions only) and the Administrative Department of Environmental Protection;

(g) The Transitional Department of Labour and Social Welfare to perform responsibilities and functions of the Administrative Department of Labour and Employment and the Administrative Department of Health and Social Welfare (social welfare responsibilities and functions only);

(h) The Transitional Department of Transport and Communications to perform responsibilities and functions of the Administrative Department of Transport and Infrastructure and the Administrative Department of Post and Telecommunications;

(i) The Transitional Department of Public Services to perform responsibilities and functions of the Administrative Department of Public Services, the Administrative Department of Local Administration, the Administrative Department of Civil Security and Emergency Preparedness and certain responsibilities and functions of the Administrative Department of Justice; and

(j) The Transitional Department of Agriculture, Forestry and Rural Development to perform responsibilities and functions of the Administrative Department of Agriculture, Forestry and Rural Development.

## Section 2 Heads of Transitional Departments

During the transitional period covered by the present Administrative Direction, the responsibilities of Co-Heads of the JIAS Administrative Departments shall be discharged by the Principal International Officers appointed to head the respective Transitional Departments by the Special Representative of the Secretary-General.

## Section 3 Entry into Force

The present Administrative Direction shall enter into force on 4 October 2001 and shall remain in effect pending the establishment of provisional self-government in Kosovo pursuant to UNMIK Regulation No. 2001/9 and the assumption by the Executive Branch of the responsibilities and functions set out in UNMIK Regulation No. 2001/19.
