REGULATION NO. 2003/11

**AMENDING UNMIK REGULATION NO. 1999/14
ON THE APPOINTMENT OF REGIONAL AND
MUNICIPAL ADMINISTRATORS**

The Special Representative of the Secretary-General,

Pursuant to the authority given to him under United Nations Security Council resolution 1244 (1999) of 10 June 1999,

Taking into account United Nations Interim Administration Mission in Kosovo (UNMIK) Regulation No. 1999/1 of 25 July 1999, as amended, on the Authority of the Interim Administration in Kosovo, UNMIK Regulation No. 1999/14 of 21 October 1999 on the Appointment of Regional and Municipal Administrators, and UNMIK Regulation No. 2000/45 of 11 August 2000 on Self-Government of Municipalities in Kosovo,

Recalling Executive Decision no 2002/17 of 18 December 2002 on the Transfer of Responsibility for Financial Administration to Municipalities,

In conformity with the Constitutional Framework for the Provisional Self-Government in Kosovo (UNMIK Regulation No. 2001/9 of 15 May 2001),

For the purpose of amending UNMIK Regulation No. 1999/14 in order to change the functional designations of Regional Administrators and Municipal Administrators, and providing related clarifications,

Hereby promulgates the following:

Section 1
Amendment

Where used in UNMIK Regulation No. 1999.14, references to “Regional Administrator(s)” are hereby amended to read “UNMIK Regional Representative(s)”, and references to “Municipal Administrator(s)” are hereby amended to read “UNMIK Municipal Representative(s)”. Consequential changes shall apply to other UNMIK legislative and executive issuances where such references appear.

Section 2
Clarification of Authority, Functions and Responsibilities

2.1 Pending a comprehensive review of the legislative framework for self-government of municipalities in Kosovo, UNMIK Regional Representatives shall have the authority and functions as set out for Regional Administrators in UNMIK Regulation No. 1999/14, and UNMIK Municipal Representatives shall have the functions and responsibilities as set out for Municipal Administrators in UNMIK Regulation No. 2000/45, subject to adjustments and changes resulting from the implementation of the Constitutional Framework for Provisional Self-Government in Kosovo and UNMIK legislative and executive issuances reflecting the transfer of responsibilities to the Provisional Institutions of Self-Government.

2.2 In the foregoing context, UNMIK Regional Representatives and UNMIK Municipal Representatives shall be governed in the performance of their day-to-day duties by Directives or Guidelines to be issued under the authority of the Special Representative of the Secretary-General.

Section 3
Implementation

The Special Representative of the Secretary-General may issue administrative directions for the implementation of the present Regulation.

Section 4
Applicable Law

The present Regulation shall supersede any provision in the applicable law which is inconsistent with it.

Section 5
Entry into Force

The present Regulation shall enter into force on 17 April 2003
