REGULATION NO. 2007/12

AMENDING UNMIK REGULATION 1999/3 ON THE ESTABLISHMENT OF THE CUSTOMS AND OTHER RELATED SERVICES IN KOSOVO

The Special Representative of the Secretary General,

Pursuant to the authority given to him under the United Nations Security Council resolution No. 1244 (1999) of 10 June 1999,

Taking into account United Nations Interim Administration Mission in Kosovo (UNMIK) Regulation No. 1999/1 of 25 July 1999, as amended, on the Authority of the Interim Administration in Kosovo,

In conformity with sections 8.1(c) and (f) of the Constitutional Framework for Provisional Self-Government in Kosovo (UNMIK Regulation No. 2001/9 of 15 May 2001),

Having promulgated UNMIK Regulation No. 1999/3 of 21 August 1999, as amended, on the Establishment of the Customs and other Related Services in Kosovo,

Acting at the request of the Government and having consulted the Economic and Fiscal Council,

Whereas Annex I to UNMIK Regulation No. 1999/3, as amended, sets out the goods exempt from customs duties, which have a zero rate of customs duty and the goods which may be released for free circulation at a zero rate of customs duty on account of their end-use,

For the purpose of amending Annex I to UNMIK Regulation No. 1999/3, as amended, in order to extend the lists of goods which have a zero rate of customs duty and which may be released for free circulation at a zero rate of customs duty on account of their end-use,

Hereby promulgates the following:

Section 1 Amendment

As of the date on which the present Regulation enters into force, Annex I to UNMIK Regulation No. 1999/3, as amended, shall be amended and replaced by the Annex I attached to the present Regulation.

Section 2 Entry into Force

The present Regulation shall enter into force on 1 March 2007

Annex I

Part A

List of Goods Exempt from Customs Duties

Exports.

Imports of goods for official use by diplomatic representatives and liaison offices in accordance with UNMIK Regulation No. 2000/42 of 10 July 2000 on the Establishment and Functioning of Liaison Offices in Kosovo.

Imports of goods for official use by the United Nations or any of its organs including UNMIK (as defined in UNMIK Regulation No. 2000/47 of 18 August 2000 on the Status, Privileges and Immunities of KFOR and UNMIK and Their Personnel in Kosovo), the specialized agencies of the United Nations, KFOR, the International Committee of the Red Cross (ICRC) and entitled and duly authorized international organizations operating in Kosovo.

Imports of goods funded from the proceeds of grants made to UNMIK or through UNMIK for Ministries and Departments (Provisional Institutions of Self Government) by governments, government agencies, governmental or nongovernmental organizations in support of humanitarian and reconstruction programs and projects in Kosovo.

Specific imports of goods which the SRSG determines are to be used exclusively for humanitarian purposes and are not to be offered for sale for consumption in Kosovo.
